



HARROW EAST REPORT

Methodology:

- Survey of n=500 respondents with a max margin of error of +/-4.4 percent at a 95 percent confidence interval.
 - Respondents were Harrow East residents and eligible to vote in UK General Elections.
 - Minimum quotas set by age, gender, region, education, occupation, tenure and ethnicity, and data weighted where necessary to ensure it is representative of the constituency.
 - Telephone poll between 2nd – 3rd August.
 - Soft voters are those voters who are undecided or likely to change their mind. They are the key group of voters that will decide the election outcome.

2017 General Election Results

Summary:

Voters in Harrow East think that Brexit is the most important issue facing the country (33%) but they are unhappy with the Government's handling of the negotiations (60%).

Whilst most are aware of the Chequers Brexit Deal (69%) over a third in Harrow East oppose it (37%) with only 22% supporting the Deal.

Voters in Harrow East expect it will have a negative effect on both the country (42%) and them and their families (37%).

Voters don't think it respects the EU Referendum results (39%), or that it is reflective of a true Brexit (48%).

Consequentially, respondents say that if their local Conservative MP supported the Chequers Deal, they would be less likely to support them at the next election (25%).

Q) If a General Election was held today, what is the most important issue that would determine if and how you vote? That could be any local or national issue or political figure or party that is relevant to you in determining your vote if a General Election was held today.
